13. That additional sections/higher classes should not be opened without prior permission of the competent authority.
14. That the recognition is accorded to society and no other society or body can open a school on their behalf.
15. That recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
16. That society shall provide, the necessary material even if it costs more than the deposit amount.
17. Admission should be made on the basis Record Sheet issued by the private Recognized/ZP/Govt. Aided Schools only TCs/certificates issued by the Secretary, DCEB as Bonafide candidate.
18. The Educational Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Government from time to time by the end of April every year as per reference 5<sup>th</sup> cited.
